

Toward Developmentally Appropriate Practice: A Juvenile Court Training Curriculum

Module 1 Adolescent Development

This module provides participants with a working knowledge of key aspects of adolescent development and their application to decision making at critical junctures in the juvenile court process.

Module 2 Screening, Assessing, and Evaluating Youth

This module provides professionals with information about forensic evaluations, as well as screening and assessment instruments used in juvenile justice systems.

Module 3 Special Education and Disability Rights

This module provides an overview of education-related disabilities, the laws pertaining to special education and disability rights, and the relevance of special education and disability rights for juvenile courts.

Module 4 Legal Questions about Youth's Capacities

This module reviews the legal questions in delinquency cases that require information about youth's capacities, including the validity of waivers of *Miranda* rights, the voluntariness of confessions, the competence of youth to participate in the legal process, and the transfer of youth to criminal court.

Module 5 Communicating with Youth: Interviews and Colloquies

This module describes techniques for effective communication with youth involved in the juvenile court system, including respondents, witnesses and complaining witnesses.

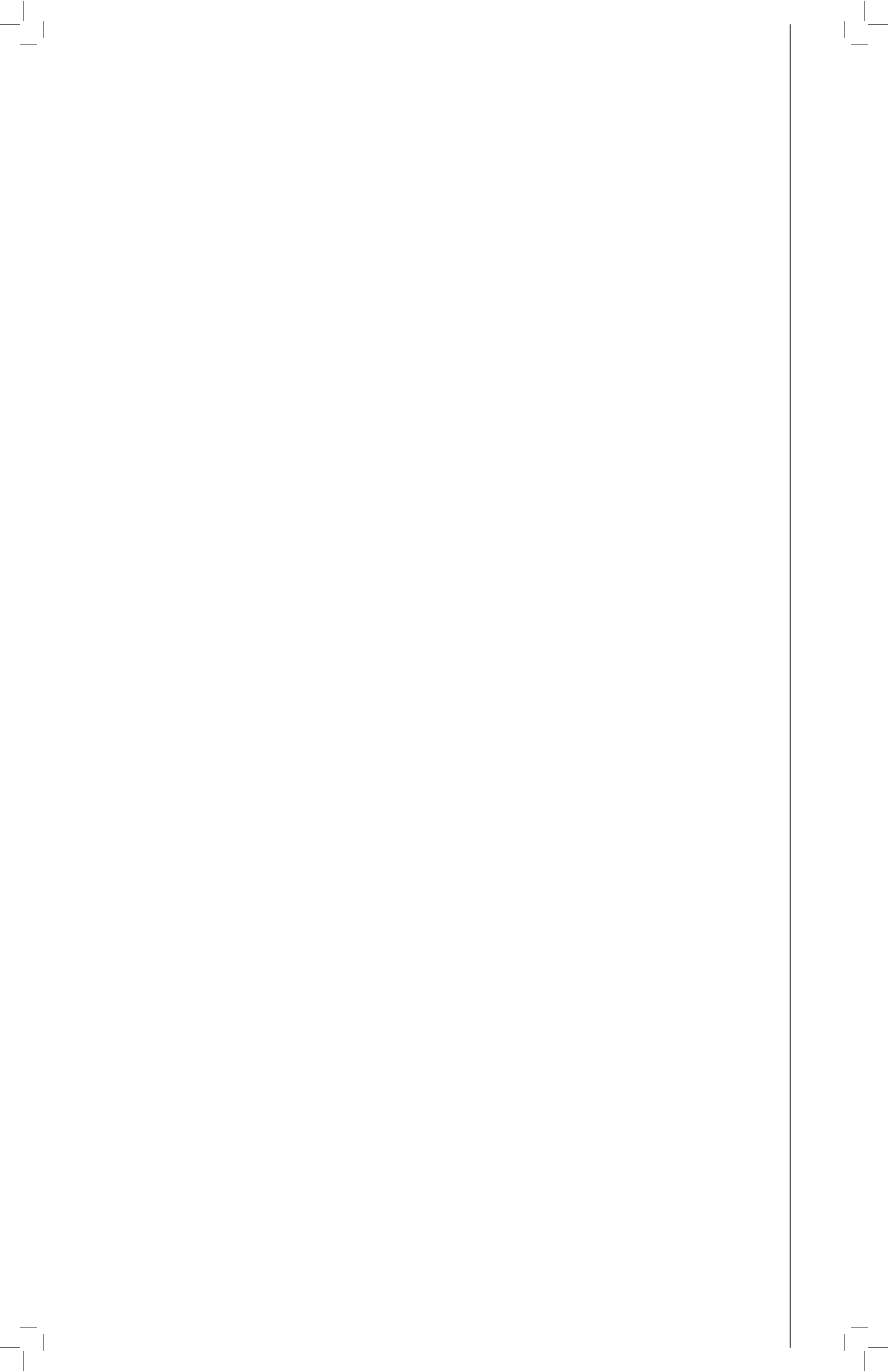
